ABSENTEE BID FORM

- 1. Registration: To register for absentee bidding, Dallas Auction Gallery (DAG) requires a current driver's license and a valid credit card on file for authorization. All successful bids will be charged a 19.5% buyer's premium for the portion up to and including \$200,000 and 12% on any portion over \$200,000 and any applicable Texas sales tax in addition to the hammer price. By submitting an absentee bid(s), you agree that you have read, understand, and are bound by the Terms & Conditions of Sale of DAG which are available online at www.dallasauktiongallery.com or at our offices.
2. PAYMENT - Domestic Clients: We accept bank wire transfer, cash, personal or company check with proper ID, cashier's check, money order, Visa, MasterCard, or American Express. Your credit card will be charged the day after the auction. If other payment arrangements have been made and good funds have not been received by the 5th business day after the auction, your credit card will be charged. If paying by check, DAG reserves the right to hold all purchases until the check has cleared to the satisfaction of DAG and its bank. International Clients: We accept bank wire transfers, Visa, MasterCard, or American Express. For items purchased via phone or absentee bidding, your credit card will be charged the day after the auction. If other payment arrangements have been made and good funds have not been received by the 5th business day after the auction, your credit card will be charged. Please note: There is a maximum of \$25,000 that may be charged to credit cards, per client invoice.
3. Shipping: It is your responsibility to arrange for and pay for shipping. All purchases should be removed from our premise by 5:00 pm on the 5th business day following the auction. Items not removed by the specified time will be subject to storage charges of \$10 per item per day. For a list of recommended shippers please check the "Shipping" link on our homepage at www.dallasauktiongallery.com.
4. DAG offers absentee bidding as a convenience to clients who are unable to attend the auction and will not be held responsible for error or failure to execute bids. In the case of identical absentee bids, the first bid received will take precedence. The lot(s) will be purchased at the lowest possible price possible. By filling in the +1 or +2 column, you authorize DAG to bid one or two increments over your maximum bid. No open ended or "buy bids" will be accepted.
5. Absentee bids must be for a minimum of 50% of the low estimate.
