PHONE BID FORM

1. **REGISTRATION:** To register for absentee bidding, Dallas Auction Gallery (DAG) requires a current driver's license and a valid credit card on file for authorization. All successful bids will be charged a 25% buyer's premium for the portion up to and including \$100,000, 20% on the portion from \$100,001 through \$1,000,000, and 12% on the portion exceeding \$1,000,000, and any applicable Texas sales tax in addition to the hammer price. By submitting an absentee bid(s), you agree that you have read, understand, and are bound by the Terms & Conditions of Sale of DAG which are available online at www.dallasauctiongallery.com or at our offices.

2. **PAYMENT – DOMESTIC CLIENTS:** We accept bank wire transfers, cash, cashier's checks, and personal or company checks with proper ID. **WE DO NOT ACCEPT ANY CREDIT CARDS UNLESS PRESENTED IN PERSON.** There is a maximum of \$10,000 that may be charged to credit cards, per client invoice. For clients not attending the auction in person, we will email you an invoice the day after the auction. Payment is due within five business days. If paying by check, DAG reserves the right to hold all purchases until the check has cleared to the satisfaction of DAG and its bank.

INTERNATIONAL CLIENTS - We accept bank wire transfers only. We will email you an invoice the day after the auction and payment is due within five business days.

3. **SHIPPING:** It is the buyer's responsibility to arrange for and pay for shipping. **On the 30th calendar day following the auction, all lots that have not been removed from DAG will be moved to an off-site storage facility and incur storage fees of \$10.00 per lot per day until removed.** For a recommended list of shippers and a Shipping Authorization Form, please click the "Shipping" link under the "Services" tab of our homepage at www.dallasauctiongallery.com. We must have a signed, completed Shipping Authorization to release your lots.

4. DAG offers phone bidding as a convenience to clients that are unable to attend the auction. We will try to reach you several lots before yours, however DAG will not be held responsible for not being able to reach you on the phone or to execute your bid on the phone.

Please note that our Terms & Conditions of Sale have changed regarding forms of payment and shipping. Due to changes with credit card company policies, we are only able to process credit cards presented in person.
